The perfect blend of historic and contemporary. The General Shoe Company purchased this property in the early 1940s and began manufacturing leather boots here during World War II. It since has been home to boat manufacturing, roofing supply, stone fabrication and even a vinyl pressing facility with United Records Press.

Today it is the home of WELD where hundreds of creative minds join daily to dream up and tackle freelance projects together. It's an innovative, open-aired, contemporary space sitting just 3 miles from downtown Nashville in the heart of the 8th Ave and Melrose neighborhoods.

Out of the building's 20,000 square feet, WELD's private event venue occupies 2,100 square feet of clean slate space. Boasting tall ceilings, white walls, and plenty of natural light, it's the ideal environment for dinner celebrations, corporate meetings, photo shoots, and launch parties.

## **Reserving the Space**

An initial 50% non-refundable deposit and signed contract is required to secure the space and your date. Booking are confirmed with a 50% non-refundable deposit.

The 50% non-refundable balance is due 30 days prior to your event.

## **Insurance**

We require all clients to provide proof of \$1,000,000 personal & ADV injury, \$2,000,000 general aggregate/Comp/OP Aggregate insurance. WELD and 12th Table must be listed as additionally insured and proof of insurance must be submitted to the Event Manager no later than 5 business days prior to your event.

## **Alcohol**

We allow you to serve beer and wine with the appropriate documents and licenses provided by the State of Tennessee. There will be no purchase or selling of alcohol on WELD's property.

## **Decor and Set-Up**

The goal for your event is that it comes to life exactly how you imagined it. So dream big. Additionally, through our rental partner 12th Table, we're able to offer an exclusive 10% discount on their rental inventory.

That said, we do want to be mindful and protective of the space so as many people as possible can enjoy it. To that end, we don't allow:

- Anything taped or adhered to the walls.



- Nails, tacks, glue or push pins. Think freestanding decor and creative suspension.
- Open flames (candles are allowed but must be in a container that has at minimum 4 inches between flame + opening)
- Glitter
- Fireworks
- Confetti canyons
- Spray Paint
- All decor that would create permanent change or alterations to space in any way must be pre-approved.
